Statements for Parents and Guardians

- ✓ I agree that my child(ren) are being enrolled in Calvin Christian School (“CCS”) primarily because of my sincere desire that my child(ren) receive a Christ centred education.

- ✓ I will support the school in its effort to provide education that is distinctively Reformed Christian and am committed to upholding and maintaining the fundamental unity of the home and the school.

- ✓ I agree to have my child(ren) educated in accordance with the confessional basis and purposes of CCS.

- ✓ I understand that enrollment is subject to the governing authorities of CCS, which reserves the right to accept or reject any student.

- ✓ I understand that CCS does not discriminate on the basis of race, gender, colour, or national or ethnic origin or any other ground prohibited by the *Human Rights Code*, in the administration of educational policy and admission, and in the availability and implementation of its programs.

- ✓ I agree, individually and on behalf of my child(ren), to review, comply with, and support the application of the school's rules, regulations and policies as may be amended from time to time, including, without limitation such rules, regulations and policies as outlined in the Student Code of Conduct and other literature distributed. Furthermore, I support any disciplinary action or decision made by the school, its principal, or their delegate with respect to the enrolment of the student at CCS. I understand that I have a responsibility to familiarize my child(ren) with the rules, doctrinal and theological positions of CCS and their obligation to know and accept these.

- ✓ I will actively support CCS, its Board of Directors (“BOD”), administration, teachers and staff through prayer and participation in school activities. I understand that parents/guardians play an important role in the education of children and can support the efforts of the CCS staff in maintaining a safe, inclusive, and respectful learning environment for all students. I agree to fulfil our role by:
 - showing an active interest in our child(ren)'s activities and progress;
 - communicating regularly with the school;
 - helping our child(ren) be excited and prepared for attending CCS;
 - promptly reporting to the school our child(ren)'s absence or late arrival;
 - showing that I am familiar with school rules;
 - encouraging and assisting our child(ren) in following the rules of behaviour set out in the rules; and
 - assisting school staff in dealing with any issues involving our child(ren).

- ✓ I agree to promptly notify CCS of any changes to the contact information on file for the student, parent(s)/guardian(s), and emergency contact, as well as any changes to the student's medical information.

- ✓ I have read the CCS Status and Rights of Membership document and agree to abide by its provisions including the lifestyle of members section. I acknowledge that failure to do so could result in the termination of my membership in the school society and the exclusion of my child(ren) from CCS.
