 - ✓ must sign a completed application form
 - ✓ agrees to subscribe to the Corporation the sum of twenty five dollars if called upon in the event of liquidation
 - ✓ Agrees to pay the annual membership fee of \$300.

Community supporters who do not have children enrolled at Calvin Christian School may apply for membership in the Corporation. Calvin Christian School does not discriminate on the basis of race, colour or national or ethnic origin, and gender.

The prospective member meets the membership requirements, accepts the Holy Bible as the infallible Word of God, and agrees to comply with the requirements and provisions as may be set forth in the Status and Rights of Membership and/or the by-laws of the Corporation. The membership application is subject to the governing authorities of Calvin Christian School, which reserves the right to accept or reject any application.

- Abide by the objects, bylaws and resolutions of the Corporation and the policies and directives of its Board of Directors.
